### **Microbusiness Approval / Denial Notice:**

Today, Missouri's Division of Cannabis Regulation (DCR) issued forty-eight marijuana microbusiness licenses to top applicants drawn in the August 28, 2023 lottery. The Department was required to issue the licenses no later than October 4, 2023 per Article XIV. Six microbusiness licenses were awarded within each of the eight Missouri congressional districts. Of the six in each district, two are microbusiness dispensary licenses, and four are microbusiness wholesale facility licenses.

Prior to issuing the licenses, the Department conducted a review of the drawn applications to determine whether applicants were eligible to receive a license. If a top drawn application did not meet application requirements, the next application from the drawing list was reviewed.

Approved applicants should check the email for the designated contact for their approval notice and acceptance letter containing additional instructions. Pursuant to 19 CSR 100-1.060(6)(D) the letter must be completed, signed, and returned to the department within **forty eight (48) hours** or the license will be subject to deactivation

A denial notice containing the reasons for the denial has been issued to applicants determined to not meet application requirements. Any denied applicant may seek review of the denial through the Administrative Hearing Commission or may request a refund of the application fee. Qualifying applicants not chosen by lottery are eligible for a refund if the applicant certifies it met the criteria for a license and has no pending or future litigation. The Department will begin accepting refund requests November 2, 2023. Requests for a refund must be requested by submitting the Microbusiness Application Refund Request form. The form and refund instructions will be available on the Department website by that date.

If, after a license has been issued, the Department determines a licensee provided false or misleading information in the application, the license may be revoked. See 19 CSR 100-1.020(3)(C).
