- I. Greeting and Introductions – Samuel Knox, SW Alliance Chair
Thanked everyone for joining the meeting. Everyone introduced themselves.

- II. Cancer Prevention Research Study – Cheryl Clay, NAACP
They have partnered with the American Cancer Society in a program called C3P. They are looking for minorities, 30-65 yrs of age who are cancer free, to volunteer for a nationwide confidential study. Kansas City Springfield and St. Louis are test sites for Missouri. They will draw blood and in 3 years will send out a letter to follow-up. - III. Menthol in Cigarettes & FDA Regulations/Report on “Deaths From Second Hand Smoke Exposure” – Mike Carter
Menthol: In 2009, President Obama signed a bill establish the tobacco control act. This gave the FDA (Federal Drug Administration) authority over the tobacco drug use. The FDA has taken out the other substances, and now, the issue is whether to take out menthol. It is believed that the tobacco industry left in menthol to target a large group of users in the U.S., specifically the African American and Hispanic communities.

The National African American Tobacco Prevention Network (NAATPN) is lobbying for the FDA to remove menthol. There are studies that show menthol in cigarettes was left in by the tobacco industry to target African

Americans and Hispanics. Fifty percent of deaths in African Americans are attributed to smoking related illnesses, which includes heart disease, diabetes, and lung cancer (72% for White and 42% for Hispanics).

The three major tobacco companies are Phillip Morris – Malbaro, Lorillard – Newport, R.J. Reynolds - Cools and Salem (no longer on the market). Eight out of 10 Black youth smoke Newport cigarettes because of the menthol.
